



Prize Terms & Conditions

1. Purpose of the Contest

This promotion aims to organize a contest among participants who register through the webpage https://www.spain.info/en/torremolinos-pride/win-trip/

2. Participants

All individuals over 18 years old who correctly register on the webpage within the participation period may participate in the contest. Employees of the Instituto de Turismo de España, TURESPAÑA, their immediate family members, and individuals professionally connected with this promotion are not eligible to participate. Participants must be residents of the European Union.

3. Participation Period

The participation period for the contest will begin on June 19 at 00:00 hours and end on July 7 at 23:59 hours.

4. Contest

- 4.1. To participate in the contest, interested parties must register on the webpage https://www.spain.info/en/torremolinos-pride/win-trip/ by providing their complete and accurate personal information.
- 4.2. Each participant is entitled to a single entry. Duplicate entries will be disqualified.
- 4.3. The prize will be randomly assigned through an automated selection system among all participants who meet the established conditions.

5. Prize

The prize consists of:

- o Round-trip airfare for two people from Greece to Malaga.
