



Prize Terms & Conditions

- 2. Participants:** The contest is open to individuals aged 18 and above who successfully register on the webpage within the specified participation period. Employees of the Instituto de Turismo de España (TURESPAÑA), their immediate family members, and individuals professionally linked to this promotion are not eligible to participate. Participants must be residents of the United Kingdom.
- 3. Participation Period:** The contest will run from July 1, starting at 10:00 a.m., until July 6, closing at 11:35 a.m.
- 4. How to Enter:** To take part in the contest, participants must register on the webpage <https://www.spain.info/en/contest/win-trip-galicia/> by providing complete and accurate personal information. Each participant is allowed only one entry, and any duplicate entries will be disqualified. The winner will be chosen randomly through an automated selection system from all eligible participants.

 - Round-trip airfare for two people from any UK airport with direct flights to Santiago de Compostela.
